

No. 387(Sanction)-RD/IAY/17F-06/2012 dt. 26th March, 2014 for implementation of construction of dwelling units under the scheme "ADHIKAR" under Special BRGF which is kept in the Adhikar Paschim Medinipur Zilla Parishad Savings Bank account of UBI, Sepoybazar branch, Midnapore.
