ORDER

An amount of Rs. 21.34 lakh (Rupees Twenty one lakh thirty four thousand only) out of Previous balance of Rs. 8.76 + interest Rs. 13.28) of Rs. 22.04 (Rupees twenty two lakh four thousand) only available under IAY during the year 2012-13 is hereby sub - allotted to Midnapore Sadar Panchayat Samiti for disbursement to 44 no. IAY beneficiaries during 2012-13 under PWI of RHS P2=2 category.

In pursuance of order No. 6710/RD(IAY)/17S-1/2010 dt. 28.10.2010 of Panchayat & Rural Development Department, Govt. of West Bengal, the enhance rate of unit assistance for an IAY house is Rs. 48500.00 w.e.f. 1.4.2010.

- i. The present sub allotment is made to the Panchayat Samiti following the revised procedure delineated in order no: 4906/RD/IAY/17S - 04/06 dt. 28.7.09 of the Principal Secretary, P & RD Deptt. Panchayat Samiti shall open separate bank account, if not already opened, and inform this office of the details of account so as to enable it to transfer fund to the respective account quickly.
- ii. Submit a certificate to the effect that all eligible beneficiaries with score P₂=1 have been assisted or under the process of being assisted under IAY and that no eligible beneficiary in the Permanent Waitlist with P₂=1 has been left out.
- iii. Before making disbursement, Panchayat Samiti shall make it sure that the person in permanent wait list as submitted by them, is actually in need of dwelling house and belongs to P₂=1 category as per RHS. In no case disbursement shall be made to ineligible beneficiary.
- iv. Disbursement shall be made at Block Level in a camp mode on prior arrangement and intimation shall be given to Zilla Parishad, SDO and operating bank branches. Application for loan at Differential Rate of Interest (DRI) shall be collected from the beneficiaries at the time of disbursement.
- v. Panchayat Samiti shall abide by other terms and conditions as laid down by State Govt./MORD in the implementation of IAY.
- vi. Progress report shall be submitted on monthly basis as usual.
- vii. Disbursement shall be made in order of priority as per wait list and social status wise stipulated coverage i.e. 60% SC/ST, 15% Minority and 3% physically handicapped must be ensured.
