ORDER


An amount of Rs. 141.12140 lakh out of the balance of Rs. 170.49886 lakh available under IAY is hereby sub – allotted to 3 nos. Panchayat Samiti as per break up given in the Annexure for disbursement to left out IAY beneficiary under P2=1 category.

- ii. The present sub allotment is made to the Panchayat Samiti following the revised procedure delineated in order no: 4906/RD/IAY/17S – 04/06 dt. 28.7.09 of the Principal Secretary, P & RD Deptt. Panchayat Samiti shall open separate bank account, if not already opened, and inform this office of the details of account so as to enable it to transfer fund to the respective account quickly.
- iii. Before making disbursement, Panchayat Samiti shall make it sure that the person in list as submitted by them under memo no. noted in the annexure, is actually in need of dwelling house. In no case disbursement shall be made to ineligible beneficiary.
- iv. Disbursement shall be made at Block Level in a camp mode on prior arrangement and intimation shall be given to Zilla Parishad, SDO and operating bank branches. Application for loan at Differential Rate of Interest (DRI) shall be colleted from the beneficiaries at the time of disbursement.
- v. Panchayat Samiti shall abide by other terms and conditions as laid down by State Govt./MORD in the implementation of IAY.
- vi. Progress report shall be submitted on monthly basis as usual.
- vii. The fund is meant for specific beneficiary only. Hence, disbursement should not be made amongst double the member of beneficiary.




