Sealed tender is invited from the bonafide and experienced firm/press/printers registered for Print and supply of four colour fasson 270 GSM glossy gum striker (size 10 inch/7 inch) under Mission Nirmal Bangla of Paschim Medinipur Zilla Parishad . The intending agencies are requested to submit the rate in sealed envelope as per schedule.
