

Scaled quotation is invited from the registered firm for internal verification of ODF (Open Defecation Free) villages of self declared ODF Gram Panchayats under Mission Nirmal Bangla of Paschim Medinipur Zilla Parishad. The intending agencies are requested to submit the rate in scaled envelope as per schedule.

1.	Last date for submission of quotation	02/06/17, upto 3PM
2.	Opening of quotation	3:30 PM

The intended quotationers are requested go through the terms and condition as given below:-

- 1) The agency must have past experience of the said work.
- 2) The quotationer has to submit documents in proof of enlistment and past experience on similar type of works.
- 3) The intending quotationer has to submit rate in his office pad only. No quotation paper will be provided from this end.
- 4) The quotation has to be submitted in the tender box kept at the Chamber of the Secretary, Paschim Medinipur Zilla Parishad.
- 5) The quotation will be opened in the Chamber of the Secretary, Paschim Medinipur Zilla Parishad.
- 6) Any quotation received without scaled envelope or without requisite paper will be treated as cancelled.
- 7) Verification team shall verify 5% of households of all the villages in the self declared ODF Gram Panchayats in random sampling Method. This team has to verify the education institutions, probable OD spots etc as per protocol.
- 8) Rate should be quoted for verification of each Gram Panchayat excluding of all taxes for the said work.
- 9) Verification team must organize meeting with ASHA/ICDS workers to derive intensive and precise information/data. Proper documentation has to be done by the agency. Report of the verified villages have to be submitted on daily basis.
- 10) The Authority may verify the authenticity of the documents submitted by the quotationer.
- 11) The Authority will reserve right to cancel any quotation without showing any reason.
- 12) The payment process will be finalized during agreement with the lowest bidder.
