The pre-qualification documents alone will be opened on 25.08.2017 (Friday) at 10.00 Hours. by the Executive Engineer, Paschim Medinipur Zilla Parishad in presence of bidders.

Names of the technically qualified bidders on the basis of information furnished in the checklist and in "My Document" uploaded by concerned bidders after verification of the same with original, will be displayed in the portal and this office notice board subject to completion of verification and technical evaluation.

The financial bid documents of the technically qualified bidders will be opened after scrutiny subjected to completion of technical evaluation and verification of original document. List of financial comparison chart of bidders will be published. No separate intimation will be given online. No individual intimation will be given and the same shall place before tender committee for their recommendation and put up for acceptance according to decision by the authority of Paschim Medinipur Zilla Parishad.

The Executive Engineer, Paschim Medinipur Zilla Parishad /Zilla Parishad Authority reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover and at least 60%(sixty percent) of which is from civil engineering construction works) equivalent to amount given below: -

1 .i) 60% of amount put to bid (cost of construction only) in case of the amount put to bid is Rs. 200 lakh and less.

ii) 75% of amount put to bid ( cost of construction only) in case of the amount put to bid is more than Rs. 200 lakh for which bid has been invited . The turnover will be indexed at the rate of 8% for a completed financial year.

2) a) The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type i.e. RCC Bore Pile Bridge having sufficient experience and having sufficient equipment and experience at least 40% value of the proposed contract within the last 5 years. For credential it will be followed the Amended rule under Rule 226 (1) of PWD code volume –I vide publication 04 – A /PW/0/10C-02/14 dated : 18.03.2015 from PWD accounts branch, NABANNA Howrah.

b) Details BAR Chart program should be given without fail.

3) Income Tax return should be submitted for last 5 years.(scan copy )

4) The Contractor should have necessary Bid capacity to execute the work (documentary evidence in proof of the above four items should be enclosed)

5) Trial balance or accounting sheet on the turnover, debit, credit position at least for the three years (Audited)

6) Vat/Sales Tax & Professional Tax clearance certificate & Pan Card, paying slip of (EM, bid document) (Xerox copy) should be furnished (Scan Copy).

7) To qualify for a Bridge scheme of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts.

The amount of earnest money is 2% of the estimated cost for “**Construction of Bridge over Champa Khal at Bankati mouza, Garbeta-I P.S. area in the District of Paschim Medinipur (RIDF-XXII)**”

(8)(a) To qualify technical bid, the agency should submit sufficient paper of total station /theodolite with surveyor associated with the firm.

(b) Minimum one structural engineer with 05 years' experience on such type of bridge should be associated with the firm. This will be viewed for technical bid qualification.

All duties, taxes, royalties, Cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.**

To keep the Bridge in good condition during the next three years after the completion of the construction if any additional / excess work is required over the stipulated quantity in the schedule for routine maintenance work, the same will be treated as defect liability and the contractor has to do the maintenance work at his own cost.

**All documents should be submitted to the Bidders1 & Bidders2 file/folder for the purpose of Technical Evaluation.**

Time allowed for completion of this work is one year and six months from the date of issue of work order.

The intending bidders are requested to inspect the site of the proposed Bridge as well as details estimate/ GAD/ Reinforcement drawing and Design water way foundation and super structure, go through SBD details before quoting their rates.
