Name of the qualified bidders will be displayed **in the office notice board.**

The Executive Engineer/District Engineer, Paschim Medinipur Zilla Parishad reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover and at least 50% of which is from civil engineering construction works) equivalent to amount given below: -

- 1).The turnover will be indexed at the rate of interest 8% for a completed financial year.
- 2)The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least one-third value of the proposed contract within the last 5 years.
- 3)Income Tax return should be submitted for last 5 years.
- 4)Sales Tax & Professional Tax clearance certificate & Pan Card (Xerox copy) paying slip of (EM, bid document) should be furnished (Scan Copy).

1)To qualify for a Package of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts.

The amount of earnest money is 2% of the estimated cost for “**Repair and maintenance of first floor of administrative building within Zilla Parishad compound, Paschim Medinipur (1st part).**”

All duties, taxes, royalties, Cess, [including 1% Cess under W.B.
