- d) Desire for engage qualified and competent firms havings integrated multidisciplinary teams of key personnel for preparing such project report of these of Paschim Medinipur .  
The consulting firm in their experience of interest shall incorporate the following qualification information in technical Bid

- iii) Annual turn- over for last five years

- v) Give details scope of work from your end

#### Other important information

- i) a) Water way related data , Topsheet Mouza Map etc. of the work may be collected by the agency concerned by his own arrangement and cost for sub soil exploration 6-8 No Bore holes are to be done up to a depth of 30m-35m from average bed level .Four to five Bore holes are to be done in river bed and out of remaining 2 – 3 Bore at each abutment .
- b) Water way vetting should be done from Central Design Office , Salt Lake , then design i.e. total DPR should be vetted by competent Engineer of P&RD/PWD Deptt. and upto satisfaction of NABARD in case of RIDF& in case of other fund it should be satisfied by the concerned Department.
- ii) Agreement bond on non-judicial stamp of Rs. 10.00 to be executed with the authority of Paschim Medinipur Zilla Parishad within seven days after letter of acceptance.
- iii) Authority of Paschim Medinipur Zilla Parishad to reserves the right to reject any tender /quotation without assigned any reason.
- iv) Proportionate security deposit @ of 10% will be deducted from all running and final Bill.
- v) If required the D.P.R may have to be modified / revised etc as per instruction of authority of Z.P & Department without any cost .
- vi) The rate should be including of all types, tolls , cess, service tax etc payable to the state Govt. and Government of India and charge for detailed design on the basis of axle load , drawing, preparation of design calculation, drawing showing working drawing on booklet of seven copies, i.e. D.P.R seven copies with layout drawing and details template of reinforcement .
