The pre-qualification documents alone will be opened on 30.11.2016(Wednesday) at 11.30 Hours. by the Executive Engineer, Paschim Medinipur Zilla Parishad in presence of bidders.

Names of the technically qualified bidders on the basis of information furnished in the checklist and in “My Document ” uploaded by concerned bidders after verification of the same with original, will be displayed in the portal and this office notice board subject to completion of verification and technical evaluation.

The financial bid documents of the technically qualified bidders will be opened after scrutiny subjected to completion of technical evaluation and verification of original document. List of financial comparison chart of bidders will be published. No separate intimation will be given online. No individual intimation will be given and the same shall place before tender committee for their recommendation and put up for acceptance according to decision by the authority of Paschim Medinipur Zilla Parishad.

The **Executive Engineer**, Paschim Medinipur Zilla Parishad /Zilla Parishad authority reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover and at least 50% (fifty percent) of which is from Electrical works) equivalent to amount given below: -

- 1) The applicant in the same name and style as bona fide contractor should have successfully completed at least one contract of same type of work at least 30% value of the proposed contract within the last 5 years having engagement on electrical supervision.
- 2) Income Tax return should be submitted for last year.(scan copy)
- 3) Vat/Sales Tax & Professional Tax clearance certificate & Pan Card, paying slip of (EM, bid document) (Xerox copy) should be furnished (Scan Copy).
- 4) To qualify for such Electrical works of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts.

The amount of earnest money is 2% of the estimated cost for “**Internal Electrification work at First Floor Office Building of Deputy Director Animal Resource Development and Parishad Officer in the District of Paschim Medinipur.(Deposited fund by ARDD).**”

All duties, taxes, royalties, Cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.**

To keep the Electrical work in good condition during the next three year after the completion of the construction if any additional / excess work is required over the stipulated quantity in the schedule for routine maintenance work, the same will be treated as defect liability and the contractor has to do the maintenance work at his own cost.

All documents should be submitted to the Bidders1 & Bidders2 File/ Folder for the purpose of Technical evolution.

Time allowed for completion of package is one month from the date of issue of work order.

The intending bidders are requested to inspect the proposed site before quoting their rates.
