The pre-qualification documents alone will be opened on **09.12.2014,(Tuesday)** at **11.30 A.M.** by the **Executive Engineer**, Paschim Medinipur Zilla Parishad in presence of bidders.

The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders will be declared after Technical evolution and the other bid documents will be unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given in News dailies. No individual intimation will be given. Name of the qualified bidders will be displayed **in the office notice board**.

The **Executive Engineer**, Paschim Medinipur Zilla Parishad reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover and at least 50% of which is from civil engineering construction works) equivalent to amount given below: -

- 1).The turnover will be indexed at the rate of interest 8% for a completed financial year.
- 2)The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least one-third value of the proposed contract within the last 5 years.
- 3)Income Tax return should be submitted for last 5 years.
- 4)Sales Tax & Professional Tax clearance certificate & Pan Card (Xerox copy) should be furnished (Scan Copy).

1)To qualify for a Package of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts.

The amount of earnest money is 2% of the estimated cost for "**Construction of Anganwadi Centre at Malam (Malam G.P.) of Nayagram Panchayat Samity area in the District of Paschim Medinipur [RIDF-XIX]**" All duties, taxes, royalties, Cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.**

The intending bidders are requested to inspect the site of the proposed AWC before quoting their rates.

The Bidders who have submitted bids in early call for the same AWC scheme i.e. (NIT - **PMD/N-97/2014-15(2nd call PMD/N-34/14-15)**) may revised their quoted rates. In that case they have to submit bids afresh along with cost of bidding document and requisite earnest money otherwise their earlier bids will be consider along with the bids submitted against this NIT.
