**Packaging and Distribution of Vegetable seed Minikits Packets for supply to 29 (Twenty Nine)
Panchayat Samities of Paschim Medinipur District**

Terms & Conditions

1. Successful Tenderers shall have to execute an Agreement with the Office of the District Officer, Horticulture, Paschim Medinipur on a **Non-judicial Stamp Paper** of Rs. 100/- (Rupees one hundred) only within the date specified in the letter of intimation.
2. The intending Tenderers shall have to furnish the copy of the PAN, Current I.T., Professional Tax Clearance, Credential Certificate, etc. from the appropriate authority along with the application.
3. Rate should be quoted including VAT if applicable.
4. No tender will be accepted without Earnest Money.
5. Each page of Tender shall be signed by the Tenderer before submission of Tender Paper.
6. The kind of supply must be written on the envelop.
7. Distribution of minilits should be made to 29 (Twenty nine) Panchayet Samities of Paschim Medinipur District with the own cost of the successful Tenderer.
8. The tenders, which do not fulfill any of the above conditions or incomplete in any respect, are liable to be summarily rejected.
9. Payment will be made from the Office of the District Horticulture Officer, Paschim Medinipur after receiving report successful delivery to 29 blocks.
10. The authority reserves the right to reject or accept any or all tenders without assigning any reason whatsoever.
11. The authority is not bound to accept the lowest tender.
12. If the successful tenderer denied to accept the offer letter then his Earnest Money will be forfeited. In case of failure to complete the supply work within the stipulated time, his offer letter will be cancelled and Security Deposit will be forfeited without assigning any reason thereof.
13. In the event of tender being submitted by a purchaser / supplier, it must be signed by each member thereof and in the event of absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so.
14. The Tenderer shall have to submit the attested photocopy of all related documents along with the tender paper.
15. All papers shall be verified with the originals.
16. The packaging should be made in good quality cloth bag of suitable size (6"x8") and the packet should consist of the items as mentioned in Annexure-I. The seeds which are already packet in sealed packet should be packet in cloth bag.
