Sealed tenders are invited from bonafied Nurseryman having engaged in production of minor fruit saplings for supply of good quality plants/saplings of Ber (budding/grafting), Bael (grafting), Sapota (grafting), Waterapple (air-layering), Jackfruit (grafting), Jamun (grafting*/seedling*) to the different blocks of Paschim Medinipur District of West Bengal, the details of which are given below. Terms and conditions:-

- 1. Successful Tenderers shall have to execute an Agreement with the Office of the District Officer, Horticulture, Paschim Medinipur on a Non-judicial Stamp Paper of Rs. 100/- (Rupees one hundred) only within the date specified in the letter of intimation. The cost of Non-judicial Stamp Paper of Rs. 100/- is to be borne by the willing tenderer.
- 2. The intending Tenderer(s) shall have to furnish the copy of the documents related to Credential of work, VAT (if any), PAN, Trade Licence, and other related documents.
- 3. No tender will be accepted without Earnest Money.
- 4. The intending Tenderer(s) will have to mention the source of mother plants and the authority may check the same at any point of time.
- 5. Each page of Tender shall be signed by the Tenderer before submission of Tender Paper.
- 6. The kind of supply must be written on the envelop.
- 7. Name & address of the tenderer and the item for which tender is to be deposited should be superscribed in block letters on the top of the envelop.
- 8. Supply of Saplings should be made to the 29 Panchayat Samities of the District of Paschim Medinipur with the own cost of the successful Tenderer (The Block-wary allocation will be furnished with the Supply Order)
- 9. A supply order will be issued from the office of the undersigned after accepting the same. Tenderer must supply the item within stipulated time period as will be mentioned in the supply order, failing which his tender may be cancelled and earnest money will be forfeited. No hike of rates will be allowed later on.
- 10. The tenders, which do not fulfill any of the above conditions or incomplete in any respect, are liable to be summarily rejected. Any deviation from the standard as required if found any time by the authority, the same will have to be replaced within specified time.
- 11. The total rate of the six component of the composite kit namely saplings of Ber, Bael, Jamun, Sapota, Jackfruit and Water apple should be considered in the Tender instead of the rate of individual items. Payment will be made from the Office of the District Horticulture Officer, Paschim Medinipur in such a manner that 60% of the total payment will be made after getting satisfactory delivery report from the 29 Panchayat Samities and rest 40% amount will be paid 90 days after 1st payment considering the satisfactory Field Report
- 12. The entire quantity of the materials should be supplied within 30 days after issue of the supply Order.
- 13. The authority reserves the right to reject or accept any or all tenders without assigning any reason whatsoever.
- 14. The authority is not bound to accept the lowest tender. Acceptance / cancellation of the tender will depend solely on discretion of the authority and the authority is not bound to accept the lowest quotation if found unsuitable.
- 15. If the successful tenderer denies to accept the offer letter then his Earnest Money will be forfeited. In case of failure to complete the supply work within the stipulated time, his offer letter will be cancelled and Security Deposit will be forfeited without assigning any reason thereof.
- 16. In case of successful tenderer, the Earnest Money will be released after successful completion of the supply of the planting materials to the concerned Panchayet Samities
- 17. In case of successful tenderer, the Security Deposit will be deducted from the 1st bill of the 60% of the supplied value after deducting the earnest money if required

- 18. In the event of tender being submitted by a tenderer, it must be signed by each member thereof and in the event of absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so.
- 19. The Tenderer shall have to submit the attested photocopy of all related documents along with the tender paper.
- 20. All papers shall be verified with the originals.
- 21. The Security Deposit Money will be refunded after successful delivery of the items and getting satisfactory field report
- 22. Tenderer should supply the item as per required specification
- 23. No claim for any subsequent increase in market price of anything more than the rates offered / quoted by the Tenderer shall be entertained.
- 24. Rate quoted includes everything including transportation up to block level, etc. and the tenderer will quote their rate accordingly.
- 25. District Officer, F.P.I. & Horticulture, Paschim Medinipur reserves the right to issue Tender Forms / Documents and accept or reject any tender thereof without assigning any reason whatever and not to be bound to accept the lowest tender.

The Specification of the Saplings to be supplied along with source of mother

- 1. The Saplings should be of Good Quality having a good physical appearance
- 2. The composite kit includes the following saplings
 - I. Ber: Budded /grafted saplings, height more than 45 cm, Variety- Banarasi Karka, Narikelee, BAU
 - II. Bael: Grafted saplings, height more than 45 cm., variety- Mirzapur, Kagzi Gonda or other improved varieties.
 - III. Jamun: Grafted Saplings* / Seedlings*, height more than 60 cm. variety-Rajamun or other improved varieties
 - IV. Sapota: Grafted saplings, height more than 50 cm, Variety-Kalipatti, Calcutta Special, Cricket Ball
 - V. Jackfruit- Grafted, height more than 50 cm, Variety-Baramasi, Hazari
 - VI. Water apple (Jamrul): Air-layered saplings, height more than 50 cm, Variety-Improved high yielding varieties bearing large size white and pleasant sweet Fruits.
 - * In case of Jamun the rate quoted for supply of vegetatively propagated saplings should be provided priority instead of seedlings. In such case atleast 4 nos. of tenderers will quote the rate for vegetatively propagated saplings otherwise the rate for supply of Jamun Saplings generated through seed propagation will be considered in the Tender Process. In this case a Tenderer may quote two separate rate for supply of Jamun Saplings generated through (i) Vegetative propagation (ii) through seed propagation. So that, If sufficient nos. of rate will not be available in case of Jamun Saplings generated through Vegetative Propagation, his quoted rate for Jamun Seedlings produced through seeds will be considered instead of saplings produced through vegetative method of propagation.

Two separate sealed envelopes addressed to the District Officer, F.P.I. & Horticulture, Paschim Medinipur, one containing technical specification along with necessary documents and the other containing the commercial specification along with earnest money are required to be deposited superscribing the purpose clearly on the top of the sealed envelope(s). Both the sealed envelopes are required to be submitted inside one single envelop addressed to the District Officer, F.P.I. & Horticulture, Paschim Medinipur and superscribing the purpose clearly on the top of the envelop. Technical specification will be opened first followed by commercial specification. The participants who will not be able to satisfy the technical specification his commercial bid will not be opened further.

Earnest money amounting to Rs. 25000/- (Rupees twenty five thousand) only is to be deposited by open Bank Demand Draft/Deposit at Call Receipts drawn in favour of District Officer, F.P.I. & Horticulture, Paschim Medinipur, payable at Midnapur along with tender documents, without which the tender(commercial bid) will be treated as cancelled. Earnest money of the successful tenderer will be kept in the office and will be released after completion of the supply of the item up to block level.
